The products can be packed in different formats: from 50 grams up to 5 kilos.

The **round** package (right) presents two horizontal welds, a vertical one and a squared base, giving it the typical "cushion" shape.

Four-weld package (left) is characterised by a more defined, square profile.

Although the most commonly used films are **traditional plastic films**, we are happy to offer an eco-friendly alternative: we have recently added **100% compostable film** packaging to our range of services.

Conventional films can be transparent or matt; the compostable film has an almost milky appearance.

All films can be printed, which allows the packaging to be customized with the customer's brand design; this option is used in high turnover products (from 15,000-20,000 pieces/year per print subject). In this case, the start-up costs include the printing equipment (175€ per colour plate). At BMS, only the highest quality films are used, which are suitable for **contact with foodstuffs** following current regulations and have a high **barrier** to gas and water vapour. The packaging of the products takes place in a **controlled atmosphere**, which allows the shelf life of the products to be extended compared to packaging in a natural atmosphere, as oxidative reactions and the development of aerobic micro-flora are considerably slowed down.

The packs are placed in **corrugated cardboard boxes**, on which a logistics label can be applied, and then placed on EPAL pallets (returnable or invoiced for €10/each), which are then packed for shipping the customer. For HORECA packages, the **pallet box** can be used as an alternative.

Labels can be applied to the front and back of the package. For the packaging to be recyclable, the labels on conventional packages must be in PP or PE. For compostable packaging, the labels must comply with EN 13432:2002.

In addition, our packaging machines are equipped with thermal transfer **markers** that allow us to print directly onto the film: we generally print TMC and batch on the side of the pack, but it is also possible to print, for example, the product name on the front or product information on the back.

The customer is always responsible for creating the graphic design, content, printing and overprinting. BMS will provide the technical-legal information, which is responsible for the person packaging the product, to comply with the mandatory requirements

The label can be supplied directly by the client in rolls conforming to our specifications for automatic labelling: **internal diameter 40mm, maximum external diameter 185mm, maximum dimensions 80x120mm, and minimum dimensions 50x70mm**. The direction of unwinding will be communicated following acceptance of the offer.

Alternatively, we can have your labels printed at our trusted print shop: between 1000 and 5000 labels per graphic subject; it is convenient to use **digital printing** (faster and more flexible for small quantities, but also more expensive, no printing equipment is needed), while for runs of over 5000 per graphic subject, **flexographic printing** is preferred (slower and with higher start-up costs, but also cheaper on large runs). For flexographic printing, you must also consider the cost of the equipment (one for each colour used). The price per piece of equipment varies from 15€ to 30€ + VAT, depending on the complexity and size of the label. The cost of the dies is between 110€ and 150€, depending on the size and shape.



The labels provided by the print shop can be applied as they are to the packaging or can be **overprinted**. This solution is ideal if you want to have a "basic" label pre-printed in the print shop, then customized in BMS by overprinting black text (left, e.g. for a line comprising several products), and you plan to print more than 5000 labels per print subject.

The headcard (right) is the alternative to the label and



is applied to the pack using eyelets. The suitable size for the packages we produce is 80x280mm or 90x260mm.

The time required to produce the labels depends on the type of product and the printing method chosen:

Label approval:

- Organic product: 10-20 working days >>> label subject to control by our quality department and approval by the certification body
- Conventional product: 2-5 working days >>> label subject to control by our quality department

Label production in the print shop:

- Flexographic printing: 10-20 working days >>> involves setting up the printing equipment (3-5 days) and then actual printing (5-15 days)
- Digital printing: 3-10 working days
